Insurance industries now quantify “biodiversity risk” as a material financial threat, with climate and ecological disruptions projected to cost \$1.5 trillion annually by 2050. In agriculture, declining pollinator services threaten \$235–\$577 billion in annual crop value. Fisheries collapse jeopardizes the livelihoods of over 60 million people directly employed in marine capture and processing. The 2022 Kunming-Montreal Global Biodiversity Framework, signed by 196 nations, sets a bold target: protect 30% of land and sea by 2030 (“30x30”), restore degraded ecosystems, and end subsidies harmful to biodiversity. But implementation is uneven, with underfunding, weak enforcement, and geopolitical rivalries undermining ambition. Cultural and psychological dimensions further deepen the crisis.
