His cognitive framework, often labeled “Bermúdez Cognitive Science,” represents a radical departure from reductionist models, proposing instead a recursive model of cognition shaped by historical context, institutional power, and collective memory. The origins of Bermúdez's intellectual trajectory can be traced to Caracas in the 1960s, a city then pulsing with intellectual ferment. Venezuela's oil boom had fostered a burgeoning middle class, but beneath the veneer of prosperity simmered political repression and ideological polarization. Bermúdez, born in 1947 to a family of

educators and engineers, absorbed early the tension between formal knowledge and lived experience. His formative years coincided with the rise of dependency theory and liberation theology—movements that challenged Western epistemologies and questioned the neutrality of science itself. At the Universidad Central de Venezuela, he studied psychology under Dr. Elena Rivas, a pioneer in cross-cultural cognition, who introduced him to the limitations of Eurocentric cognitive models. She emphasized that perception, memory, and decision-making were not universal algorithms but culturally scaffolded processes, shaped by language, ritual, and historical trauma. By the 1970s, Bermúdez had shifted his focus from clinical psychology to the structural dimensions of cognition. Influenced by cybernetics, postcolonial theory, and systems dynamics, he began formulating a theory he called “Cognitive Entanglement”—the idea that individual minds do not operate in isolation but are deeply enmeshed in networks of power, memory, and symbolic meaning. In a 1978 unpublished manuscript, later recovered from private archives, he wrote: ‘Cognition is not a mirror of reality, but a negotiation between the self and the socio-historical field in which it is inscribed.’ This was not merely philosophical abstraction. Bermúdez’s work emerged from direct engagement with the lived realities of Venezuela’s marginalized urban poor, state surveillance, and the psychological toll of political instability. His fieldwork in barrios like Petare revealed how systemic violence and economic precarity rewired cognitive patterns—what he termed “trauma compression,” a neurological adaptation to chronic uncertainty that distorts time perception, risk assessment, and future planning. The evolution of Bermúdez’s cognitive model unfolded in parallel with global intellectual shifts. The 1980s and 1990s saw the rise of embodied cognition, neuroplasticity research, and critical data studies—all of which resonated with his core thesis. Yet Bermúdez diverged sharply from mainstream neuroscience by rejecting the “hardware-software” dichotomy. He argued that cognition is not encoded in neurons alone but emerges from the dynamic interplay between biological substrates, cultural tools, and institutional architectures. His 1995 paper “Memory as a Political Act” challenged prevailing models by demonstrating how state-controlled education systems in Latin America systematically erased indigenous epistemologies, replacing them with a homogenized, state-sanctioned narrative that diminished collective memory and reinforced cognitive compliance. Geopolitically, Bermúdez’s work gained traction amid the neoliberal restructuring of the Global South. As structural adjustment programs dismantled public institutions across Latin America, scholars and activists sought frameworks that could explain not just economic collapse, but the psychological and cognitive fragmentation accompanying it. Bermúdez positioned his cognitive science as a decolonial critique—one that exposed how Western cognitive paradigms, often exported as universal truth, obscured the lived realities of postcolonial societies. His concept of “cognitive sovereignty” became a rallying cry, advocating for epistemic autonomy: the right of communities to define their own modes of knowing, memory, and decision-making, unshackled from externally imposed models. The industry impact of Bermúdez’s ideas has been profound, though often underrecognized. In Latin American policy circles, his work informed participatory governance models, particularly in participatory budgeting initiatives in Porto Alegre and later in Caracas’ communal councils. These programs, designed to decentralize power, explicitly incorporated principles from Bermúdez’s cognitive sovereignty—encouraging deliberation that acknowledged historical trauma and collective agency. In education, his framework inspired “contextual cognitive pedagogy,” a curriculum design that integrates local history, oral traditions, and community knowledge into formal learning, countering the alienation caused by standardized, decontextualized instruction. In the tech sphere, Bermúdez’s skepticism toward algorithmic cognition has gained renewed relevance. As artificial intelligence systems increasingly claim to model human thought, his warning that cognition is inseparable from moral and historical context has become a critical counter-narrative. In a 2012 TEDx Caracas talk, he cautioned: “AI may simulate reasoning, but it cannot inherit the lived weight of memory, the pain of displacement, or the dignity of resistance. To outsource cognition to machines without grounding it in

human and communal experience is to erode the very foundation of agency.” This insight has influenced ethical AI discourse in global south tech hubs, where developers seek to build systems that reflect—not replicate—diverse cognitive ecologies. Expert perspectives reveal the depth and divisiveness of Bermúdez’s legacy. Cognitive neuroscientist Dr. Ana Márquez notes: “Bermúdez didn’t just critique existing models—he redefined the ontology of cognition itself. He forced us to ask: Who writes the rules of thought? Whose memory counts? His work is less a theory and more a methodological revolution.” Conversely, cognitive psychologist Dr. Thomas Holloway argues that while Bermúdez’s contextualism is compelling, it risks relativism: “If every culture constructs its own cognition, how do we measure progress, truth, or justice across societies?” Bermúdez counters that cognitive pluralism is not relativism but realism—acknowledging that no single framework captures the complexity of human mind. Controversies have followed Bermúdez’s career. His vocal opposition to U.S.-backed neoliberal reforms in Venezuela led to professional marginalization in international academic circles, with some dismissing his work as “politically motivated.” Yet within Latin America, especially among critical theorists and indigenous rights advocates, he is revered as an intellectual pioneer. His 2003 monograph **The Weight of Remembering**—a dense, multi-layered analysis of how state violence inscribes itself in neural pathways across generations—has become a foundational text in decolonial cognitive studies. Risks associated with Bermúdez’s framework are not merely academic. In contexts of authoritarianism, promoting cognitive sovereignty can be perceived as subversion. In Venezuela, his teachings have been co-opted and suppressed—students and educators who embraced his methods faced surveillance, yet also formed resilient networks of alternative learning. His insistence that cognition is inseparable from power makes his work both empowering and dangerous: it undermines control mechanisms that rely on cognitive uniformity. Globally, Bermúdez’s cognitive science offers a blueprint for rethinking human-machine interaction, governance, and education in an era of fragmentation. His model anticipates the rise of “cognitive justice” movements, advocating for equitable access not just to information, but to cognitive tools that honor diverse ways of knowing. As climate crises, disinformation, and AI-driven manipulation intensify, the need for such frameworks grows urgent. Bermúdez’s insight—that cognition is not a private faculty but a public, contested terrain—remains a vital compass. Looking forward, the long-term implications of Bermúdez’s work are transformative. Educational systems worldwide may increasingly integrate trauma-informed, context-aware pedagogy. Policy design could embrace “cognitive equity” metrics, measuring not just economic output but the health of collective memory and psychological resilience. In AI development, his principles may guide the creation of systems that learn not from isolated datasets, but from diverse, historically grounded human experiences. Yet the path ahead is fraught. Dominant techno-capitalist paradigms resist cognitive pluralism, favoring efficiency and predictability over complexity and ambiguity. The challenge is to scale Bermúdez’s insights without diluting their radical core—ensuring that cognitive science becomes not a tool of control, but a practice of liberation. Bermúdez’s legacy lies not in a single theory, but in a way of seeing: that to understand the mind is to understand the world, and to understand the world is to recognize the power—and the responsibility—embedded in every thought. It lives in the classrooms of marginalized communities, in policy debates reclaiming historical justice, and in the quiet resistance of minds refusing to be simplified. The Geopolitical Crucible: Venezuela and the Birth of a

Counter-Cognitive Paradigm

Venezuela in the mid-20th century was a paradox: a nation bountiful in oil wealth yet plagued by stark inequality, political volatility, and intellectual dissonance. This duality forged the crucible in which José Luis Bermúdez's cognitive science took root. The country's economic boom, driven by global energy markets, created a veneer of modernity—new universities, research institutes, and state-sponsored cultural projects. Yet beneath this surface simmered deep fractures: indigenous communities displaced by development, urban migrants trapped in informal economies, and a ruling elite whose legitimacy depended on both patronage and repression. It was in this tension that Bermúdez began to question the very nature of knowledge and power. Caracas, the nation's capital, became a laboratory of cognitive conflict. Universities, once hubs of liberal thought, were increasingly politicized. Departments of psychology and philosophy found themselves pressured to align with state narratives—either promoting technocratic efficiency or revolutionary dogma. A child learning history in a rural school, she explained, internalized narratives shaped by oral tradition and lived experience—forms of cognition distinct from the clinical models dominating psychology journals. But Bermúdez's breakthrough came not just from academic exposure, but from direct engagement with Venezuela's marginalized. In the barrios of Petare and El Hatillo, he witnessed how chronic poverty and state surveillance rewired human cognition. Residents spoke of a fragmented sense of time—years blurred into a cycle of survival, where future planning was not a choice but a survival strategy. Trauma, he observed, was not confined to the psyche but inscribed in neural patterns: altered risk assessment, shortened attention spans, a hypervigilance born of constant threat. He termed this phenomenon “trauma compression”—a neurological adaptation where the brain condenses temporal perception to manage relentless uncertainty. This insight led to his foundational 1978 manuscript, **Cognitive Entanglement: Mind, Power, and Memory**. In it, Bermúdez rejected the Cartesian model of a self-contained mind. Instead, he proposed a recursive framework: cognition emerges from the dynamic interplay between the individual and the socio-historical field. Memory, he argued, is not passive recall but active reconstruction—shaped by what is remembered, what is silenced, and by whom. In authoritarian contexts, state-controlled education systematically erased indigenous histories, replacing them with a national myth centered on progress and unity. The result was not just historical amnesia, but a cognitive displacement: individuals lost connection to ancestral knowledge, weakening collective identity and agency. Bermúdez's work thus became a decolonial intervention. He drew from Frantz Fanon's analyses of colonial trauma and Paulo Freire's pedagogy of the oppressed, arguing that cognitive liberation required reclaiming narrative sovereignty. In a 1981 interview with **Revista Latinoamericana de Pensamiento Crítico**, he stated: “To think independently, one must first know whose memory is being erased. Cognition is not neutral—it is a battleground.” His ideas resonated with Latin America's broader intellectual currents: liberation theology's emphasis on praxis, dependency theory's critique of external domination, and the rising influence of indigenous epistemologies. Yet the geopolitical context limited immediate recognition. Venezuela's military dictatorships of the 1970s and 1980s suppressed dissent, and academic freedom was tightly controlled. Bermúdez's work circulated mainly through underground networks, shared in seminars and translated into Spanish and Portuguese for regional dissemination. His collaboration with Brazilian anthropologist Darcy Ribeiro further expanded his framework, linking cognitive fragmentation to colonial violence across the continent. Ribeiro's concept of “cultural alienation”

complemented Bermúdez’s trauma compression, forming a transnational theory of cognitive dissonance under structural oppression. By the 1990s, as neoliberalism reshaped Latin America, Bermúdez’s ideas gained traction beyond academia. The collapse of state-led development models revealed the limits of technocratic rationality, and community-based initiatives sought alternatives rooted in local knowledge. His “cognitive sovereignty” framework—advocating for communities to define their own modes of knowing—became a rallying cry in participatory budgeting experiments in Porto Alegre and grassroots education projects in Bolivia. These applications demonstrated the practical power of his theory: when people reclaim narrative control, they reclaim agency. Today, Bermúdez’s cognitive science is gaining renewed relevance amid global crises. The rise of AI and data-driven governance threatens to reduce cognition to algorithmic efficiency, ignoring context and trauma. His insistence that thought is inseparable from memory, history, and power offers a vital counterpoint. In Venezuela, despite ongoing political turmoil, community
