The geopolitical context of the late 1980s was pivotal. The Cold War’s waning years saw renewed global attention to human rights, yet domestically, the U.S. was retreating into punitive orthodoxy. The war on drugs, declared in 1971, had evolved into a systemic campaign against communities of color, with incarceration rates soaring—particularly among Black men, whose imprisonment became a normalized feature of civic life. Stevenson’s early work coincided with a surge in private prisons, bail-for-cash systems that criminalized poverty, and mandatory minimums that stripped judges of discretion. His challenge was not just legal, but cultural: to reframe crime not as moral failure, but as symptom of structural failure.

Geopolitical and Economic Frameworks: The Carceral State as Global Phenomenon
