Yet, compliance is uneven. The U.S. Artemis Accords, backed by NASA and allies, promote peaceful exploration and resource use. China's CNSA, with its Chang'e missions and

plans for a lunar research station, signals long-term territorial and scientific ambitions. India's Chandrayaan program and private ventures like SpaceX and Blue Origin further fragment the landscape. This fragmentation breeds tension. In 2023, the U.S. accused Russia of developing anti-satellite weapons capable of targeting orbital assets—and by implication, lunar infrastructure. China's 2020 Chang'e-5 sample return, which retrieved 1.7 kg of regolith, underscored its growing technical maturity. Meanwhile, smaller actors—Israel, UAE, Luxembourg—have invested in lunar landers and mining technologies, raising questions about who controls access to lunar resources. Destroying the moon, in this context, could serve as a symbolic or strategic act. Transparency remains low: few nations publicly disclose their lunar disruption capabilities, let alone testing protocols.

Historically, lunar ambition has been bipolar—U.S. vs. USSR—then increasingly multipolar. Today, the U.S., China, Russia, India, and the EU lead complex lunar programs, each with distinct strategic goals. The U.S. emphasizes Artemis
