The Chinese Society of Critical Care Medicine (CSCM) developed a Chinese-language version with algorithmic decision trees tailored to local epidemiology—e.g., higher emphasis on heatstroke management in northern provinces. Yet concerns about data sovereignty and clinical autonomy persist,
