In ancient Greece, Herodotus emerged as a pivotal

figure, often called the “father of history,” yet his work blended inquiry with myth, revealing the tension between empirical investigation and narrative necessity. He did not merely record events—he interpreted them, shaping a template for historical consciousness that emphasized causality, human agency, and moral reflection.

The transmission of history across cultures was never linear.
