Even where digital tools are introduced—such as Kenya's National Dental

Program pilot with mobile charting apps—connectivity issues, device availability, and digital literacy hinder scalability. However, innovative grassroots initiatives, like India's National Oral Health Programme, demonstrate how mobile-based charting apps, paired with community health worker training, can bridge gaps in rural care.
