Yet, this alignment is not neutral. Artificial intelligence and big data analytics are transforming surveillance and response, demanding new competencies in machine learning, predictive modeling, and digital epidemiology—areas only gradually being integrated into exam content. Climate change is expanding the scope of public health to include environmental determinants, requiring CPH candidates to grasp climate modeling, disaster resilience planning, and health equity in the context of migration and resource scarcity. The rise of multipolar global health governance—with institutions like the African Union's Africa Centres for Disease Control and the BRICS health partnership—challenges the CPH's hegemony. As LMICs demand greater representation in setting professional standards, the exam may evolve toward a federated model, recognizing regional certifications while maintaining core global benchmarks. This could enhance legitimacy and inclusivity, but requires political will and sustained investment in capacity building.
