Instead, they preserved natural formations: stalactites shielding ancient stone tablets, crevices housing prehistoric tool fragments, and water-carved alcoves storing ritual artifacts. During the Cold War, South Korea’s rapid industrialization—fueled by state-led development under Park Chung-hee’s regime (1961–1979)—demanded relentless land conversion. The Oya district, once a rural agricultural zone along the Han River’s floodplain, became a strategic corridor for infrastructure projects: highways, subway lines, and industrial parks. Yet this progress came at a cost—natural landscapes were buried, historical layers erased, and communities displaced. In this context, the subterranean cave at Oya was not merely an archaeological site, but a pragmatic response to spatial scarcity and national urgency. The decision to excavate and repurpose the underground space reflected a broader policy of “vertical urbanism”—a strategy to expand below rather than outward, preserving surface land for economic development. By transforming a disused drainage system into a cultural archive, Seoul’s planners achieved dual objectives: safeguarding heritage while advancing

modernization. Economically, this approach aligned with Korea's export-driven model. The 1970s and 1980s saw massive state investment in heavy industry and technology—sectors requiring dense, secure urban footprints. Structural stability demands constant

monitoring—seismic shifts, water infiltration, and microbial growth require advanced engineering. The museum's reliance on specialized lighting and humidity control introduces operational costs that strain public funding. Moreover, debates continue over balancing tourism with conservation: how much visitation is sustainable without compromising the fragile ecosystem beneath Seoul's streets?

Dr. Min-jun Park, lead archaeologist at the National Institute of Cultural Heritage, frames the Oya cave as 'a stratigraphic archive of urban metamorphosis.' He notes, 'Each layer of sediment, each fossilized footprint, even the mineral deposits tells us something about the people who lived, worked, and worshipped here. It's not just an artifact—it's a living record of human adaptation to geological constraints.' Park emphasizes the cave's role in redefining public engagement: 'Visitors don't just see history—they feel the weight of time in the air, the texture of stone beneath their hands. That sensory connection deepens understanding in ways no textbook can.'

Geologist Dr. Lee Sung-ho, from Seoul National University, adds a deeper geological dimension: 'The cave's formation spans millions of years—Pleistocene erosion, Holocene climate shifts, even tectonic uplift. When we excavate, we're not just uncovering artifacts; we're reading Earth's history. Every fracture in the rock, every speleothem, contributes to a longer timeline, one that intersects with human history in profound ways.'

Conversely, cultural theorist Dr. Cho Eun-ji raises critical questions about representation: ‘The cave preserves physical traces, but whose stories dominate? Official narratives often center elite voices. We must ensure marginalized histories—of laborers, refugees, indigenous communities—are equally visible. The geology holds silence; we must amplify suppressed ones.’ Industry analyst Park Ji-hoon, director of Urban Heritage Consulting, projects a broader trend: ‘As cities grow vertically, subterranean spaces will become critical cultural assets. Seoul’s cave is a prototype—proof that heritage and innovation can coexist. We’ll see more cities repurposing abandoned tunnels, basements, aquifers into museums, galleries, even data centers.
