These findings have prompted IRCC to revise validation protocols, incorporating human oversight and dialectal diversity into training datasets. Within immigration services, frontline workers report mixed experiences. While Celpip's

standardized format streamlines initial screening, some case managers lament its rigidity: “It captures mechanical competence but often misses resilience, cultural adaptability, or lived experience—qualities that predict long-term success just as much as grammar.” This tension underscores a broader challenge: balancing scalability with nuance in integration policy.
