In East Asia, Japan's #KuToo movement challenged workplace and marital expectations, sparking national debate on gendered

power. Despite geographic diversity, common drivers persist: patriarchal norms, economic marginalization, weak legal enforcement, and cultural silence. The absence of gender-transformative policies across most nations sustains vulnerability.
