Economically, Mantri's model aligns with the rise of digital construction platforms—BIM, blockchain for supply chain transparency, and AI-driven predictive analytics. But he stresses that technology must serve human judgment, not replace it. As he often says: 'Data tells the story, but people write the ending.'
