Similarly, Javier Morales, a veteran narrative journalist with *El País*'s Latin America Bureau, stressed the importance of “narrative tension.” “A synopsis must create a question,” he explained. “It doesn’t need to answer it—just make the reader curious enough to turn pages, dive into sources, or demand accountability.” Morales cited his own work on a series exposing offshore financial networks tied to political elites: the synopsis opened not with a list of names, but with a single family’s struggle to access healthcare funded by hidden offshore accounts—grounding the macro in the personal. Data journalists offer complementary insights. Leila Nour, head of narrative strategy at *The Bureau of Investigative Journalism*, highlighted the role of evidence mapping: “Before writing, we map facts as a constellation—each data point a star. The synopsis is the first constellation we reveal, the one that guides the reader through the sky of complexity.” She warned against “summary fatigue,” where overuse of passive voice or bureaucratic jargon erodes engagement. Instead, she championed active, sensory language—“a \$3.2 billion embezzlement hidden in encrypted ledgers”—that makes abstract figures tangible.
