As newspapers folded and digital platforms prioritized clicks, **Chronicle** proved that public-supported, subscription-funded journalism could thrive—if rooted in trust and depth. Her insistence on long-form, contextual reporting offered a counter-narrative to the 24-hour news cycle’s shallowness. Yet challenges persist. Journalists face unprecedented threats: 2023 saw 277 journalists imprisoned globally, 40 killed, and digital surveillance tools enabling targeted
