In low-income schools lacking reliable internet or tablets, students rely on outdated print editions, missing interactive elements and real-time updates. This “digital divide” exacerbates educational inequality, reinforcing patterns where marginalized communities receive less rigorous or less current science instruction. Furthermore, the textbook’s reliance on English as the primary language of instruction marginalizes non-English speakers, even in multilingual nations, unless supplementary materials are developed—resource not always available. Globally, comparative analysis reveals stark contrasts. In China, state-mandated textbooks integrate national priorities—such as renewable energy innovation and public health resilience—with rigorous content, resulting in high performance but limited critical debate. These models challenge the U.S. paradigm: science education as both a national project and a site of cultural negotiation.
