This success stems from strong governmental backing, routine updates, and mandatory training that embeds case-based learning into annual certification. In contrast, India’s experience illustrates challenges. While the National Health Authority launched a free coding portal in 2020, adoption remains uneven. Urban private hospitals embrace it; rural public health centers lack internet access or digital literacy. A 2024 survey found that 68% of rural coders still rely on outdated paper-based examples, increasing error rates. The government’s response—a mobile-first initiative with offline-capable apps and community trainer networks—demonstrates the need for context-sensitive implementation. While this has reduced billing fraud, critics note limited flexibility in adapting to emerging specialties like telemedicine or digital therapeutics. The model succeeds in standardization but risks stagnation amid rapid medical innovation.
