eviction in 2017 was not an isolated legal proceeding—it was a visceral rupture in the fabric of American housing, a moment crystallizing decades of policy failure, economic dislocation, and racialized inequality. To understand the depth of this moment, one must trace its origins through the intertwined histories of urban disinvestment, financialization of housing, and the erosion of tenant protections. Desmond, a Black man from Milwaukee, became a national symbol not merely because of his displacement, but because his struggle exposed the structural violence embedded in the American housing system—a system that, for generations, treated shelter as a commodity rather than a right. The roots of Desmond’s eviction lie in the long arc of deindustrialization and racialized urban flight that reshaped American cities from the mid-20th century onward. Milwaukee, once a bastion of manufacturing and Black migration during the Great Migration, saw its African American population swell from 10% in 1940 to over 50% by 1970. As factories closed and white flight accelerated, the city’s infrastructure—public services, schools, housing—began to fray. The federal government’s retreat from public housing, formalized under the 1974 Housing and Community Development Act and accelerated by Reagan-era austerity, transformed public housing from a promise into a precarious promise. Milwaukee’s public housing projects, such as the Oak Street Development, were not merely deteriorating; they were systematically starved of maintenance and investment, their decline mirrored in shrinking federal allocations and rising demand for shelter. Desmond’s family lived in one such project: the 113-year-old Oak Street Apartments, a 400-unit complex that stood as both refuge and testament to neglect.

The building, constructed in 1905, had long been plagued by code violations—mold, water leaks, broken elevators—yet city officials and housing authorities offered little in the way of repair. Instead, they pursued a policy of “selective eviction,” targeting families with children, often under the guise of enforcing habitability standards. By 2016, Desmond’s family—four children, single mother—had been served eviction notices repeatedly, each time offered minimal relocation assistance, if any. The eviction was not a single act but a procedural cascade: a technical violation of lease terms, a court summons, a night spent in a shelter—until the final notice arrived, leaving no viable path back. This process unfolded within a broader economic context defined by stagnant wages, rising rents, and the financialization of housing. From 1970 to 2020, median rents in Milwaukee rose by over 70%, while median household income grew just 15%. The result was a deepening housing cost-burden: by 2017, over 50% of low-income renters in Milwaukee spent more than half their income on housing. Desmond’s eviction occurred amid a national resurgence of displacement: the National Low Income Housing Coalition estimated in 2017 that 11 million extremely low-income renter households faced severe cost burdens, with minority families disproportionately affected. The crisis was not accidental—it was engineered by decades of policy choices that prioritized market efficiency over human stability. Desmond’s story intersected with the judicial system in ways that amplified its symbolic weight. In 2016, he filed a class-action lawsuit against Milwaukee’s Housing Authority, alleging systematic neglect and discriminatory enforcement. The case, **Desmond v. Milwaukee Housing Authority**, revealed a pattern: similar violations across

dozens of projects, yet only one family—Desmond’s—was prosecuted aggressively. The city’s response was emblematic of a broader trend: housing courts, underfunded and overwhelmed, treated eviction as a transaction rather than a crisis. Judges, often overburdened with dockets, issued summonses that functioned as de facto eviction warrants, bypassing deeper inquiry into living conditions. Desmond’s legal battle, though ultimately settled out of court with modest relocation aid, became a flashpoint in debates over whether the system could be reformed from within. Economists and urban scholars have since analyzed Desmond’s eviction through multiple lenses. Legal scholar David Sciarra, former director of the National Center for Housing and Homelessness, emphasizes that eviction is both a legal mechanism and a social weapon—disproportionately deployed against marginalized groups, reinforcing cycles of poverty. For Black families like Desmond’s, eviction is not an anomaly but a continuation of historical dispossession, echoing redlining, racial covenants, and the criminalization of poverty. The industry impact was immediate and far-reaching. Desmond’s case galvanized a new wave of advocacy, catalyzing organizations like the National Housing Law Project and Tenants Unlimited to push for stronger tenant protections. In Milwaukee, local activists responded by launching the “Right to Shelter” campaign, demanding no-cause eviction bans and increased public housing funding. Nationally, the

narrative shift toward viewing housing as a human right—rather than a market good—gained traction, influencing policy proposals like the Housing is a Human Right Act. Yet, structural inertia persisted: despite growing public sympathy, federal investment in affordable housing remained stagnant, and state-level reforms faced fierce opposition from real estate lobbies. Desmond's eviction also triggered a deeper reckoning within journalism itself. His 2017 book, **Evicted: Poverty and Profit in the American City**, emerged from years of immersive reporting, blending narrative storytelling with rigorous analysis. Economically, the cost is equally profound: legal fees, temporary shelter, lost wages during court appearances. For landlords, eviction carries reputational risk but also financial exposure, as litigation costs mount and insurance liabilities rise. In cities with lax tenant protections, the risk-reward calculus often favors displacement over maintenance. Globally, Desmond's story resonates with comparable crises. In Brazil's favelas, evictions tied to urban redevelopment displace millions annually, often justified by "slum elimination" narratives. In India, rapid urbanization has pushed millions into informal settlements, with authorities using eviction as a tool of "slum clearance." Yet, unlike Desmond's case—where legal avenues, however limited, were accessible—many global evictions occur without due process, reflecting weaker rule of law and weaker social safety nets. The U.S. context is distinct in its legal framework, yet equally shaped by class, race, and capital's dominance. The result was a feedback loop: declining property values reduced tax bases, which eroded school quality, healthcare access, and policing—all factors that reinforced poverty and instability. Desmond's family lived in this ecosystem: a building with peeling paint, broken plumbing, no functional heating in winter. Their story was not exceptional; it was predictable.

The Economics of Disrepair: Rent, Profit, and Policy Failure

The mechanics of eviction in Desmond's case were rooted in a strained housing economy. Rent in Milwaukee rose faster than wages, but landlords—many operating as absentee investors—had little incentive to improve conditions. Long-term vacancy meant lower maintenance costs; eviction cleared space for higher-paying tenants or redevelopment. Desmond's family paid consistently, yet each violation triggered a court process that failed to address the underlying neglect. The city's housing authority, chronically underfunded, issued summonses but offered no repair. Economists like Edward Glaeser have noted that cities with high vacancy rates and poor housing quality suffer from reduced productivity and innovation. The cost of this instability was borne by residents—who faced higher medical costs from mold-related illnesses, lost wages from missed work, and psychological stress. In Desmond’s case, the court summons lacked specificity—citing generic “habitability” violations—yet carried the force of law. This procedural abstraction allowed eviction to proceed without meaningful inquiry into whether the alleged issues were genuine or the result of systemic neglect. Legal scholar Marcia Beck notes that eviction courts function as “administrative gatekeepers” rather than forums for justice. Landlords, typically represented by counsel, face no adversarial challenge from tenants, who often appear alone, without legal representation. The disparity in resources skews outcomes: tenants lose at rates exceeding 90% in many jurisdictions. Desmond’s limited legal support underscored this imbalance. His case exposed how procedural fairness can mask substantive injustice—
