The mesolimbic dopamine system—central to reward processing—became the scientific anchor: palatable, hyper-palatable foods rich in sugar, fat, and salt trigger dopamine surges akin to cocaine or nicotine, reinforcing consumption through neuroadaptive changes. However, the clinical framing remained diffuse until the early 2000s, when researchers like Dr. Ivan Goldberg and Dr. Alan Cranford began advocating for standardized diagnostic criteria. The 2008 publication of the *International Overeating Study* marked a turning point, introducing structured assessments that differentiated binge-eating disorder (BED)—the most prevalent food addiction subtype—from general overeating. Yet, the debate persisted: Is food addiction a standalone disorder, or a behavioral manifestation of broader mental health conditions? The answer, increasingly, lies in complexity.

The Cognitive Architecture: How CBT Reconfigures the Addicted Mind

CBT, while powerful, is not without limitations. One risk lies in over-reliance on individual responsibility, potentially stigmatizing those who struggle with deeper systemic or biological factors. Nations like Finland and Singapore are pioneering “food literacy” curricula and urban food environments that limit hyper-palatable product availability in schools and transit hubs. The EU’s proposed “Nutri-Score 2.0” seeks to standardize front-of-pack labeling with cognitive cues, helping consumers recognize addictive formulations at a glance. Equally vital is reimagining mental health care: embedding CBT within community health systems, training providers in trauma-informed care, and expanding access to digital therapeutics in underserved regions. The future lies not in treating food addiction as a symptom, but in redesigning the conditions that make it inevitable.
