In Russia, for example, state media has appropriated Holocaust imagery to frame geopolitical conflicts—portraying Russian actions as defensive against Western imperialism, while invoking Soviet martyrdom as a counter-narrative of sacrifice. This instrumentalization distorts historical memory, using the Holocaust's moral authority to justify violence rather than condemn it. Conversely, in Eastern Europe, memorials and academic discourse emphasize the Holocaust's local impact, resisting Soviet-era attempts to subsume Jewish suffering into broader anti-fascist myths. These competing uses reveal allegory's dual potential: as a tool of truth-telling or as a shield for revisionism. The global comparison dimension further complicates the allegory's authority. Consider the Rwandan genocide of 1994: often framed in similar terms—"never again," "ethnic cleansing," "genocide"—yet the international response was markedly different. Unlike Nazi Germany, Rwanda's perpetrators were not foreign occupiers but neighbors, and the global community's inaction reflected geopolitical indifference. Here, the Holocaust allegory falters: invoking it risks implying a universal moral framework that fails to account for power asymmetries, colonial legacies, and selective outrage. Scholars like Mahmood Mamdani argue that such comparisons often reproduce a "civilizational hierarchy," where Western victims are presumed more legitimate than others. This critique underscores the need for humility in allegorical

comparisons—recognizing that while patterns of violence may recur, their meanings are historically and culturally contingent. Similarly, in India, the 1947 Partition violence remains a sensitive memory, invoked cautiously to resist oversimplification.
