Initial arrests targeted marginalized women—Tituba, Sarah Good, and Mary Easty—whose social invisibility made them easy targets. As accusations cascaded, even respected community members like Rebecca Nurse, a pillar of piety, and Giles Corey, a landholder who resisted coercion, were ensnared. The court's insistence on spectral evidence, combined with a presumption of guilt, transformed hysteria into a judicial apparatus of mass execution. Nineteen men and women were hanged between June and September 1692; one, Giles Corey, was crushed to death for refusing to plead. The final victim, Bridget Bishop, was hanged on June 10, 1692—the only woman executed in Salem's trials. Beyond the immediate tragedy, the crisis exposed the fragility of legal norms under religious extremism. The very institutions meant to safeguard justice—church, court, community—became complicit in a ritual of condemnation. Reverend Cotton Mather's influential but controversial treatise

Memorable Providences (1689), which legitimized spectral evidence, exemplified the theological justification for persecution.
