Yet, he remains cautious: without intentional design, decentralization risks fragmentation and loss of coherence. Leadership, for Robbins, transcends charisma or positional authority. Surveillance tools, automated performance tracking, and AI-driven decision support systems challenge the balance Robbins sought between oversight and autonomy. His model assumes a human-centered feedback loop, but in algorithmically managed workplaces, influence shifts toward data models, raising ethical questions about transparency, bias, and worker dignity.
