Geopolitically, the land's strategic value will intensify. Critical minerals, essential for batteries and solar panels, are concentrated in fragile states—Democratic Republic of Congo, Chile, Australia—where governance risks are high. The U.S.-EU Critical Raw Materials Act and China's Belt and Road Green Initiative signal a new race for sustainable resource control. Success depends on transparent, equitable supply chains that respect ecological limits and human rights. Long-term, a paradigm shift toward "Earth Stewardship Economies" is emerging—a framework where GDP is redefined to include natural capital and social well-being. The Global Biodiversity Framework's target to protect 30% of land and ocean by 2030 is a step, but only if funded and enforced. Indigenous land rights, which protect 80% of global biodiversity on just 22% of land, must be central to all conservation strategies. The land's discontents are not a warning—they are a diagnosis. They reveal a world at a crossroads: one path leads to irreversible decline, the other to regeneration. The choice is ours.
