In 2024, a sophisticated deepfake campaign—using AI-generated worker profiles—briefly destabilized a regional job-matching algorithm in Southeast Asia, underscoring the fragility of trust in hyper-connected systems. As cybersecurity expert Marcus Lin warned, “Mitchell OnDemand5 proves that digital trust is only as strong as its weakest node.
