Control over these resources fuels national strategies and international competition, particularly as global demand for green technologies surges. The Sahel's instability is thus not merely a security issue but a biome-bound crisis, where climate-driven desertification exacerbates resource scarcity, migration, and conflict. The boreal forest—Earth's largest terrestrial biome—covers 11% of the land surface across Canada, Russia, Scandinavia, and Alaska. Rich in timber, oil, and gas, it is a strategic asset for energy and industrial economies. Yet its carbon stocks are vast—twice that of all tropical forests—but increasingly vulnerable to wildfire, pest outbreaks, and industrial encroachment. Russia's Far East, for example, has seen aggressive logging and infrastructure development, raising concerns about sovereignty, indigenous land rights, and transboundary pollution. These megafires release gigatons of CO₂, destroy biodiversity hotspots, and displace populations—exposing the fragility of human settlements within dynamic biomes.
