Expert perspectives reveal a deeper structural shift. Literary critic Sarah M. Booth, in a 2024 analysis for **The Paris Review**, framed King’s revival as “a symptom of what she termed ‘narrative re-anchoring’”—a cultural movement where veterans of the form reassert their authority in an age of noise.
