Baseball, a

sport built on mythos of invincibility and American virtue, mirrored this denial. Owners, many of them older men resistant to change, viewed HIV as a moral failing rather than a medical crisis. The economic stakes were enormous: MLB's television contracts were growing, sponsorships depended on fan confidence, and the league's valuation hinged on a perceived image of health and vitality. To acknowledge HIV was to risk a cascade of absences, lost revenue, and diminished marketability. Shilts saw this not as coincidence, but as deliberate avoidance. His reporting triggered a seismic shift. In 1987,

was published to critical acclaim but also fierce resistance. Team executives denied his findings; league officials distanced themselves.
