This polyvocality mirrors the complexity of truth itself—no single narrative holds the whole, only fragments. The “wolves of mercy” now appear not just as individual figures but as systemic forces: bureaucracies that withhold truth, media that distort memory, communities that erase pain to preserve peace. The novel's setting—Mercy Falls—resonates precisely because it is rooted in real geopolitical and economic currents.
