Singapore's “City in a Garden” model integrates biodiversity into

urban design, with rooftop gardens, permeable pavements, and strict green space mandates. The environmental justice dimension reveals stark disparities. Marginalised communities—often racialised or low-income—bear the brunt of pollution, flooding, and heat stress. In the United States, census data shows that Black and Hispanic populations are exposed to 38% more industrial air pollution than they generate, while in Nairobi's Kibera slum, residents face contaminated water and landfills adjacent to informal housing. This spatial injustice reflects deeper inequities in urban governance, where development prioritises economic growth over ecological and human health. Geopolitical tensions further complicate the urban environmental equation. Water scarcity, intensified by urban demand in arid regions, fuels conflict—such as in the Nile Basin, where cities like Addis Ababa and Khartoum compete for dwindling flows. Energy transitions in urban centres, particularly in fossil fuel-dependent economies, face resistance from entrenched industries and labor structures. Meanwhile, climate migration—driven by rural environmental collapse and urban overcrowding—is reshaping demographics, with cities in South Asia and Sub-Saharan Africa absorbing millions of displaced people annually, straining resources and infrastructure.
