Grace (*charis*) becomes the catalyst for a new consciousness: sinners restored to communion with a holy God, not by works, but by faith (*pistis*) in Christ’s atonement. This doctrine of justification by faith, contested fiercely in the early Church—most notably in the Antiochene and Pelagian debates—remains the doctrinal fulcrum upon which Christian self-understanding pivots. The origins of this worldview are

inseparable from the sociopolitical matrix of the Eastern Mediterranean.
