In the Gulf, expatriate communities illustrate the intersection of kafaala systems and global labor dynamics. Women from Bangladesh, Indonesia, and the Philippines often enter marriage under contractual arrangements where exit requires employer consent—a legal trap that reinforces dependency. Recent reporting by **Al Jazeera** and **The Wall Street Journal** has documented cases where brides, trapped in abusive relationships, face deportation or social exile if they seek independence. These stories challenge the myth of Gulf modernity, revealing how tradition and globalization coexist in systems of control.

Even in high-income democracies, reluctance surfaces in marginalized communities. Among Indigenous populations in Canada and Australia, historical trauma and systemic discrimination correlate with higher rates of forced or early marriage, often concealed by cultural stigma. Indigenous journalists and activists emphasize the need for decolonized narratives—ones that center self-determination rather than victimhood.

These geopolitical realities underscore a central challenge: no single framework explains reluctant wife stories.
