Sections on humidity calibration for tropical climates, saltwater resistance for coastal use, and altitude compensation in pressurization revealed a growing awareness of food systems as inherently geographic. This shift mirrored broader economic transformations: the rise of just-in-time logistics, the erosion of local self-sufficiency, and the increasing fragility of supply chains. The manual thus evolved from a consumer gadget guide into a technical manual for resilience. The geopolitical dimension deepens when examining the V3485’s international diffusion. While initially marketed to North American households, by the early 2000s, it had become a staple in emerging economies—from urban markets in Lagos to rural cooperatives in the Andes. This penetration was not accidental.
