Films like ‘Masaan’ (2015), ‘Article 15’ (2019), and ‘Kahaani’ (2012) reinserted marginalized geographies into national discourse, using cinematic form to interrogate caste, communalism, and environmental exploitation. This evolution cannot be understood without examining the geopolitical and economic context. India's growing middle class, expanding urbanization, and digital revolution have reshaped audience expectations and distribution models. Streaming platforms like Netflix, Amazon Prime, and regional services such as MX Player and Aha have disrupted traditional theatrical dominance, enabling niche, regional, and experimental content to reach global audiences. Yet this digital shift has also intensified competition, commodifying storytelling and pressuring creators toward viral appeal. The 2020 ban of ‘Padman’ in certain regions over sensitive historical depictions, and the scrutiny faced by ‘Article 15’ during its release, illustrate the precariousness of cinematic dissent. Additionally, digital piracy, platform monopolization, and algorithmic bias threaten both artistic integrity and audience access, particularly for independent makers. Globally, *chut land ki film* finds parallels but distinct inflections. Nigerian Nollywood, for instance, shares India’s scale and regional diversity but operates with even lower budgets and higher informal production rates. Iranian cinema, constrained by strict censorship, develops poetic resistance through metaphor and subtext—offering a contrasting model of constraint-driven creativity.
