In Japan, kaiju films persist as both entertainment and societal metaphor, evolving from Cold War atomic anxiety (**Godzilla**) to contemporary ecological commentary (**Shin Godzilla**), where the monster embodies systemic collapse and human accountability. Controversies surrounding creature design are as complex as its technical foundations. The rise of deepfake technology and synthetic life forms has sparked urgent ethical debates. AI-generated creatures capable of indistinguishable mimicry risk enabling identity fraud, misinformation, and psychological manipulation.
