Embedded within were scaffolded reading passages, bilingual glossaries, and formative check-in templates, intended to support teachers in real-time instruction. The folder's launch in 2018 coincided with a broader national shift toward data-driven education, amplified by the Every Student Succeeds Act (ESSA), which incentivized states to develop individualized accountability systems. Texas positioned itself as a leader in “competency-based” learning, where fluency was not an abstract goal but a measurable outcome. Initially piloted in 12 high-need districts—Harris, El Paso, and Brown counties—the program revealed both promise and pitfalls. Teachers praised its clarity and alignment with classroom practice, but many reported shortages in bilingual support staff and inconsistent access to digital tools, especially in rural areas.

Geopolitical and Economic Context: Fluency as a Strategic Asset

Texas's economic engine thrives on transnational connectivity. Its border with Mexico generates over \$300 billion in annual trade, and its workforce interfaces daily with Spanish-speaking clients, regulators, and partners. The state's economic strategy increasingly recognizes linguistic agility as a competitive advantage. A 2022 study by the Brookings Institution found that bilingual employees in Texas's border regions earn 18% higher wages on average and are 25% more likely to occupy leadership roles than monolingual peers. Yet, this

economic imperative clashes with a long-standing cultural ethos of linguistic assimilation. Federal policies, particularly under the Obama and Biden administrations, promoted bilingual education through initiatives like Title III grants, but Texas has historically resisted mandates, preferring state-led solutions. The Texas First Fluency Folder thus reflects a pragmatic compromise: it advances English proficiency without eliminating native language instruction, acknowledging that cognitive research shows bilingualism enhances, rather than hinders, academic performance. Moreover, data privacy concerns loom large: student performance metrics, collected via proprietary platforms, are increasingly used to refine targeting algorithms and attract advertising, raising ethical questions about surveillance and consent. Singapore, meanwhile, employs a “mother tongue plus English” model, integrating language learning with cultural pride—achieving high proficiency while preserving linguistic diversity. Contrast this with Texas’s historical emphasis

Yet, like many U.S. states, Texas struggles to balance national cohesion with pluralism.
