In Sufi traditions, *dhikr* (remembrance) employs melodic repetition to achieve spiritual ecstasy—echoing the rhythmic power of *Halleluyah* chants. These analogues suggest that the impulse to sanctify sound is universal, yet *Halleluyah* stands out for its linguistic precision, its biblical anchoring, and its adaptability across contexts. Looking ahead, the *Halleluyah* Scriptures face a pivotal inflection. As artificial intelligence generates synthetic chants, blockchain archives authenticate oral traditions, and immersive technologies recreate ancient sanctuaries, the boundaries of authenticity and authorship blur.
