Its hybrid tactics, combining autonomous targeting with minimal human oversight, contrasted sharply with the 2024 U.S. and EU models, exposing a growing bifurcation in global lethal force norms. In the Global South, nations like Nigeria, Kenya, and Indonesia adopted hybrid frameworks, blending GLFA 2024 principles with localized rules addressing insurgency and civil unrest. These adaptations often emphasized rapid response while incorporating community oversight mechanisms to build trust—though implementation remains uneven due to resource constraints.

Long-Term Implications and Strategic Projections
