Meanwhile, cultural critic Edward Said—though never a contributor—epitomized the journal's ethos in his advocacy for “contrapuntal

reading,” a concept JPS embodied by centering Palestinian perspectives in historical interpretation. Controversies have inevitably shadowed JPS. Critics from both Israeli and certain Western academic circles have accused it of bias, particularly in its treatment of Zionist narratives and Israeli state policies. Defenders counter that such accusations often mask discomfort with the journal’s unwavering commitment to factual accountability.
