In China, SQL operates within a tightly controlled data environment. State-aligned data platforms enable centralized storytelling—promoting policy successes through curated reports—but independent analysis faces significant barriers. Here, SQL serves as both a tool of state narrative and a constrained resource for dissenting voices. In Latin America, SQL has become a weapon in anti-corruption investigations. The Panama Papers and Pandora Papers leaks relied heavily on SQL queries to cross-reference offshore entities, financial flows, and political connections
