Renaissance Technologies and Citadel have integrated CPC into their volatility forecasting models, identifying microstructural tipping points where sentiment shifts trigger flash crashes. Educational systems must cultivate “complexity fluency,” enabling policymakers and citizens to interpret threshold dynamics without overconfidence or fatalism. Moreover, ethical governance must precede scale. Frameworks for responsible CPC deployment—grounded in human oversight, explainability, and adaptive oversight—must evolve alongside the technology. The OECD’s recent guidelines on AI and systemic risk offer a starting point, advocating “criticality audits” and red-team testing for high-impact models.
