Similarly, TNA revised its “Injury Reporting and Rehabilitation Policy” in 2019, mandating independent medical reviews for all high-risk maneuvers. The coalition's 2022 white paper, co-authored with biomechanics experts, revealed that 82% of independent wrestlers with documented chronic injuries had experienced inadequate post-care—evidence that Hardman's early struggles were not unique but systemic.
