The risk of state collapse, fueled by corruption, ethnic polarization, and institutional weakness, remains acute in fragile states. Forward-looking projections suggest that the legacy of figures like Amin persists not in ceremonial memory, but in the quiet recurrence of executive overreach, elite impunity, and the erosion of democratic norms.
