Research from the Stanford Social Innovation Review shows that winners who commit to structured giving—whether through foundations, scholarships, or community projects—report higher life satisfaction and reduced guilt. The "giving pledge," popularized by Bill Gates and Warren Buffett, resonates particularly with lottery winners, offering a framework to align wealth with meaningful impact. Long-term planning includes estate strategy and legacy building. Trusts, charitable foundations, and multi-generational wealth plans protect assets from erosion and ensure continuity.
