Expert analysis reveals this model as a symptom and accelerator of deeper societal transformations. "Brooke Perrin is not selling marriage," observes Dr. Elena Vasiliev, a sociologist at the London School of Economics specializing in post-industrial relationships. "She is selling the idea that emotional capital—once considered non-

transferable—can now be leveraged, measured, and traded. Each context reflects not just market demand, but deeper societal negotiations over privacy, trust, and the meaning of commitment.
