When Chancellor Wilhelm Cuno resigned in 1923 after failing to repudiate reparations, and later Hans Luther struggled through economic crisis, trust in democratic mechanisms eroded. Simultaneously, the global economic order shifted. The U.S. Dawes Plan (1924) temporarily stabilized German reparations by linking payments to economic capacity, enabling a short-lived “Golden Twenties.” Investors returned, industries revived, and

a consumer culture emerged—yet this recovery was hollow. It depended on American loans, not organic growth. When Wall Street crashed in 1929, the German economy imploded. Unemployment surged past 30% by 1932, and industrial production plummeted by 45%. Factories stood idle; bread lines stretched across Berlin. The crisis was not economic alone—it was existential. As economist Adam Tooze notes, the collapse “reversed the illusion of recovery” and shattered faith in liberal capitalism. Hitler’s early political career reflected this disorientation. A failed soldier in World War I, he joined the German Workers’ Party (DAP) in 1919, a fringe group of veterans and anti-Semitic nationalists. His oratory—charged with mythic nationalism, conspiratorial anti-Semitism, and a vision of racial rebirth—resonated not because of policy coherence, but because it channeled diffuse rage. The DAP’s transformation into the National Socialist German Workers’ Party (NSDAP) in 1920 marked the birth of a movement that fused populist resentment with *völkisch* ideology. The 1923 Beer Hall Putsch, though a failed coup, was a pivotal moment. It revealed Hitler’s strategic shift: from street violence to political maneuvering. Imprisoned for 13 months, he wrote **Mein Kampf**, outlining his vision of a racially

pure “Volk,” the need for *Lebensraum* in the East, and the elimination of Jews, Marxists, and liberal elites. The Putsch’s failure taught him that power required institutional penetration, not just propaganda. By the mid-1920s, the Nazi Party began rebuilding. Key to this was Franz von Papen, a conservative aristocrat who, in 1923, convinced President Paul von Hindenburg to appoint Hitler as Secretary of State in Bavaria. This placement allowed the Nazis to infiltrate state institutions. When Hitler returned to Munich, he reorganized the party, staffing it with disciplined cadres—former soldiers, disillusioned industrialists, and skilled propagandists. The global economic freefall of 1929 transformed Germany’s trajectory. As American capital fled, German industries—already dependent on foreign loans—collapsed. Then, the Enabling Act (March 23, 1933) granted Hitler dictatorial powers, legalizing his regime without parliamentary consent. Industrial Complicity and the Cost of Conciliation

The consolidation of Nazi power was not solely the work of brute force—it relied on complicity,

particularly from industrial and financial elites. Many industrial magnates, fearing communist revolution more than Nazi ideology, saw economic survival in aligning with the new regime. The Stahlhelm, a veteran organization, and large chemical firms like IG Farben provided logistical support, funding, and personnel. Economic historian Richard Evans emphasizes that “the Nazis did not seize power alone; they were enabled by a class that feared chaos more than tyranny.” The Krupp firm, Bayer, and other industrial leaders offered loans, secured contracts, and facilitated the persecution of trade unionists and Jewish entrepreneurs. This symbiosis allowed the regime to rapidly rearm (in violation of Versailles), rebuild infrastructure, and suppress labor dissent—all while presenting itself as a return to order.

Propaganda and the Architecture of Consent

But propaganda was not mere

manipulation—it was a psychological engineering project. The regime exploited deep-seated fears: of economic ruin, racial decline, and moral decay. Anti-Semitism, long present in European thought, was elevated to state ideology. The 1935 Nuremberg Laws stripped Jews of citizenship, justified their exclusion through pseudoscientific racism, and normalized persecution. Scholar Ian Kershaw notes that the Nazis “did not invent hatred—they harnessed it.” By framing Jews, communists, and dissidents as existential threats, they created a sense of collective purpose. This narrative was reinforced by educational reform, youth organizations like the Hitler Youth, and the suppression of dissenting voices through Gestapo surveillance and book burnings.
