He was instrumental in founding the Latin American Investigative Journalism Network (LAIN), a consortium of over 40 outlets across 12 countries, designed to pool resources and share risk in reporting on cross-border corruption, money laundering, and environmental exploitation. This collaboration reflected a strategic response to the increasing criminalization of journalists: according to the Committee to Protect Journalists, El Salvador ranked among the world’s top five countries for journalist killings between 2010 and 2020, with over 30 documented murders during Esquivel Cabrera’s active years. While Western newsrooms continue to dominate international narratives, figures like him represent a growing counterweight: journalists rooted in local realities, yet connected through global networks, who challenge the extractive models of information control. His work exemplifies how investigative journalism can function as a form of transnational civic infrastructure—one that bridges borders, strengthens democratic institutions, and holds
