The Abraham Accords, normalizing relations between Israel and several Arab states, represent a pragmatic attempt at cooperation, yet they mask unresolved tensions and do not resolve core disputes.

The U.S. Inflation Reduction Act and CHIPS and Science Act, designed to reshore critical industries, reflect a move toward strategic autonomy. Similarly, the EU’s push for “strategic sovereignty” seeks to reduce reliance on external powers. These policies, while aimed at resilience, risk fragmenting global markets and escalating trade wars, potentially undermining the very stability they seek to secure.**
