Nowhere is this truer than in the examination papers issued during the first semester of 2023-2024 by Mohamed bin Salman (MBS), then Crown Prince of Saudi Arabia and de facto architect of the kingdom's transformation. These question papers, released through official channels and scrutinized by scholars, journalists, and policy analysts, are not mere academic exercises—they are artifacts of a state in strategic repositioning, navigating oil dependency, geopolitical realignment, and domestic reform. Behind the structured syllabi lies a layered narrative of ambition, risk, and the weight of expectation. This article dissects these documents with the rigor of investigative journalism, contextualizing their origins, evolution, and implications across economic, geopolitical, and institutional domains. The journey begins not with the questions themselves, but with the moment of their conception. MBS's ascension to crown prince in 2017 marked a decisive break from the cautious incrementalism of his predecessors. The appointment of a young, technocratic circle—largely drawn from royal court technocrats and younger reformists—ushered in a new era of centralized decision-making. Education, particularly in elite institutions and standardized assessment, became a critical vector for this vision. The Ministry of Education, under successive reformers, overhauled curricula to align with global benchmarks, emphasizing STEM, leadership, and critical thinking—skills purported to underpin Vision 2030. The first semester question papers, released in mid-2023, reflected this recalibration: they were not simply tests of knowledge, but instruments of cultural and institutional engineering. Geopolitically, their context was charged. The global energy landscape was shifting. The U.S. shale boom, European decarbonization pressures, and China's rising influence as a trade partner forced Saudi Arabia to reconsider its oil-centric model. MBS's push for economic diversification—articulated through Vision 2030—required a workforce fluent not only in economics but in diplomacy, innovation, and strategic foresight. The question papers mirrored this: they included cross-disciplinary prompts on energy transition, foreign investment, and soft power. For instance, one essay question asked candidates to evaluate the feasibility of Saudi Arabia leveraging its sovereign wealth fund, the Public Investment Fund (PIF), to pivot from oil to tech and renewable energy, factoring in geopolitical rivalries with Iran, regional instability, and global climate commitments. Another

tested historical awareness: how Saudi foreign policy had adapted to U.S. policy shifts under different administrations, from Obama's pivot to Asia to Trump's transactionalism and Biden's climate diplomacy. Economically, the papers signaled a quiet but profound recalibration. The first-semester assessments emphasized fiscal policy, non-oil GDP growth, and public-private partnerships—all central to Vision 2030's goal of reducing reliance on hydrocarbons. Questions probed students' understanding of fiscal breakeven oil prices, the role of subsidies in economic reform, and the challenges of privatizing state-owned enterprises. A notable item required candidates to analyze the impact of the 2020 oil price collapse and subsequent production cuts under OPEC+ on Saudi fiscal sustainability—a direct reference to the crisis that tested MBS's early leadership. The emphasis was not on rote memorization, but on applied analysis: could students project revenue shortfalls, assess the social cost of subsidy reforms, and propose mitigation strategies? Yet beneath this analytical rigor lay controversy. Critics, both within and outside Saudi Arabia, questioned whether the curriculum and assessments reflected genuine pedagogical reform or were performative, designed more for international image than systemic change. Independent observers noted persistent gaps: while elite schools adopted global teaching methods, public institutions lagged, exacerbating inequality. Moreover, the focus on state-driven development raised concerns about academic freedom. Questions on governance often framed the monarchy's role as inherently stabilizing, offering little room for dissenting viewpoints. A 2024 audit by the Gulf Center for Strategic Studies highlighted this tension: while standardized testing improved national competency metrics, it risked narrowing discourse by privileging state-aligned narratives. The industry impact of these reforms was palpable. The private sector, particularly in tech and renewable energy, reported a growing talent pipeline aligned with Vision 2030's priorities. Yet, structural barriers remained. Labor market rigidities, regional segmentation, and a legacy of state dominance in key sectors limited private sector growth. The question papers, in turn, mirrored this duality—praising innovation while underscoring systemic bottlenecks. One business administration question asked: "Assess the role of SMEs in Saudi Arabia's post-oil economy, considering regulatory, financial, and cultural constraints." The expected response demanded not just analysis, but strategic insight—recommendations on policy levers, access to capital, and cross-sectoral collaboration. From a global perspective, Saudi Arabia's educational and policy reforms stood in dialogue with other Gulf states and emerging economies. The UAE's emphasis on knowledge-based economies and Qatar's investment in education (via Education City) offered comparative benchmarks. Yet Saudi Arabia's scale—population 36 million, oil wealth, regional influence—made its experiment uniquely consequential. Unlike smaller Gulf economies, Riyadh's reforms carried continental implications, influencing economic models across the Arab world and beyond. Expert assessments were divided. Prof. Layla Al-Mansour, a political economist at King Saud University, noted: "The 2023–2024 papers reflect a deliberate effort to produce leaders fluent in global governance, not just local administration. But their effectiveness hinges on whether reform penetrates beyond elite circles. Without inclusive education access, Vision 2030 risks becoming a top-down project, disconnected from societal realities." Similarly, Dr. Tariq Hassan, a regional security analyst, observed: "The geopolitical framing in the Q&A reveals a state calibrated for survival in a multipolar world—balancing U.S. alliances, Chinese investment, and Iranian rivalry. Yet the curriculum's emphasis on stability sometimes obscures deeper questions about legitimacy and reform pace." Risks were evident in both implementation and perception. The centralization of education and assessment under royal oversight raised concerns about politicization. Whistleblowers and former educators reported pressure to align student responses with state narratives, particularly on sensitive topics like governance reform and human rights. Externally, the papers were scrutinized for signaling continuity amid uncertainty—would MBS's reforms endure beyond his personal authority? The answer, as of mid-2024, remained ambiguous. Yet the very act of publishing detailed question papers—however curated—represented a shift toward transparency, a departure from past opacity. Looking forward, the long-term implications of this educational and policy architecture are profound. If sustained, the focus on strategic foresight, innovation, and global engagement could cultivate a generation of leaders capable of steering Saudi Arabia through energy transitions, digital disruption, and shifting alliances. However, success depends on three levers: deepening institutional accountability, expanding equitable access to quality education, and fostering pluralistic discourse. Without these, the ambition risks becoming a blueprint for continuity rather than transformation. In the arc of Saudi Arabia's

modern governance, these question papers are more than academic artifacts. They are diagnostic tools, revealing the tensions between vision and execution, ambition and constraint. They expose not just what was tested, but what was avoided, deferred, or deliberately framed. As MBS's first semester papers circulated, they carried the weight of a nation redefining its place in a world where power is no longer defined solely by oil, but by knowledge, adaptability, and legitimacy. The true measure of their legacy will not lie in the scores of students, but in whether this moment marks genuine turning points—where education becomes a springboard for inclusive progress, not a ritual of control. That remains the unspoken question behind every answer.

The Geopolitical Calibration in the Classroom: How Education Reflects Saudi Arabia's Global Ambitions

The 2023–2024 MBS-era question papers were not merely academic instruments; they were geopolitical statements etched in syllabi. Beneath the structure of math problems and essay prompts lay a deliberate calibration to Saudi Arabia's evolving role on the world stage. For decades, Riyadh's foreign policy had been defined by oil diplomacy and regional security alignments, particularly with Washington. But under MBS, the kingdom sought to reposition itself as a global policy actor—balancing great powers, investing in soft power, and navigating multipolarity with unprecedented assertiveness. This shift was mirrored in educational content, where global affairs were no longer peripheral but central to assessment. One striking feature of the question papers was their emphasis on strategic foresight in international relations. For instance, multiple exams included scenario-based questions requiring candidates to analyze Saudi Arabia's diplomatic posture amid U.S. policy uncertainty, China's Belt and Road expansion, and Russia's re-engagement in the Middle East. A key item asked students to evaluate the long-term viability of the Abraham Accords from a Saudi perspective: not just assessing diplomatic benefits, but probing domestic public sentiment, regional power dynamics, and economic interdependencies. This reflected a broader recalibration—Saudi Arabia no longer viewed itself as a passive recipient of global shifts, but as an active architect. Energy geopolitics dominated another axis. As global demand for oil softened under decarbonization pressures, Saudi Arabia's narrative pivoted toward energy transition leadership. Question papers included rigorous analyses of the kingdom's role in OPEC+, its investments in green hydrogen, and partnerships with European energy firms. Candidates were challenged to project how fluctuating oil prices, carbon pricing mechanisms, and renewable adoption trends would shape Saudi fiscal policy through 2030. One exam required candidates to draft a foreign policy statement justifying continued investment in oil infrastructure while advancing solar and wind projects—balancing short-term revenue needs with long-term sustainability. This dual focus underscored a deeper tension: while the kingdom sought to diversify, its legacy reliance on hydrocarbons remained a structural vulnerability. The papers subtly acknowledged this by including critical questions on institutional inertia, bureaucratic resistance, and public perception. A political economy module asked: "Assess the challenges Saudi Arabia faces in transitioning from a rentier state to a knowledge-based economy, emphasizing institutional, social, and geopolitical dimensions." Expected responses demanded nuanced analysis of rent distribution, labor market duality, and the role of foreign expertise—without dismissing the monarchy's central role in managing change. Beyond economics and geopolitics, the papers tested cultural fluency in global governance. Students were frequently asked to compare Saudi Arabia's governance model with those of democratic and authoritarian peers, evaluating strengths and weaknesses through lenses of legitimacy, efficiency, and adaptability. This was not academic neutrality but a deliberate cultivation of strategic thinking—preparing future leaders to engage with international norms while safeguarding sovereignty. A constitutional law question, for example, asked: "Compare the legal frameworks governing public participation in Saudi Arabia and Norway, considering implications for governance and social cohesion." The prompt encouraged comparative reasoning, not rote comparison, prompting students to link institutional design to real-world outcomes. The global resonance of these reforms extended beyond Saudi borders. In countries grappling with resource dependence—Nigeria, Venezuela, Algeria—the MBS-era pedagogy offered a case study in top-down modernization. Yet, scholars

cautioned against uncritical emulation. As Dr. Amina Al-Farouq, a Gulf studies expert at SOAS, noted: “While Saudi Arabia’s emphasis on strategic education is admirable, its success depends on trust, transparency, and inclusive participation—elements often absent in rentier states. Without addressing these gaps, reforms risk reinforcing authoritarian resilience rather than enabling transformation.” Ultimately, the question papers revealed a nation at a crossroads. They projected confidence in Saudi agency, yet revealed the limits of centralized control. The curriculum framed the kingdom not as a passive player, but as a shaper of global systems—capable of influencing energy markets, diplomatic alliances, and developmental paradigms. But true agency, experts argue, requires more than state-led curricula: it demands civic engagement, independent inquiry, and a willingness to confront uncomfortable truths. In the interplay between paper and power, these documents stand as monuments to a pivotal era—one where education became both mirror and mechanism of Saudi Arabia’s quest to redefine itself in a world remade by technology, climate, and shifting great-power dynamics.

Expert Critiques and Unspoken Tensions: The Limits of Reform in the Classroom

The release of MBS’s first-semester 2023–2024 question papers sparked immediate debate—not only among educators and students, but within policy circles and international observatories. While the reforms signaled modernization, behind the polished syllabi lay a constellation of critiques revealing the fault lines of institutional change in an autocratic yet reformist monarchy. One of the most persistent critiques centered on accessibility and equity. Despite public commitments to educational reform, disparities between elite institutions in Riyadh and Jeddah and underfunded public schools in peripheral regions remained stark. A 2024 report by the Saudi Center for Educational Accountability found that only 37% of public schools in rural areas met national digital infrastructure benchmarks, compared to 92% in urban hubs. Yet the question papers assumed uniform participation, with advanced analytical and interdisciplinary tasks that presupposed access to high-speed internet, updated textbooks, and trained teachers—resources often absent outside the capital. This created a de facto meritocracy skewed toward privilege, undermining claims of inclusive transformation. Another flashpoint was the subtle but pervasive framing of political legitimacy. While overt dissent remained impossible, the curriculum’s treatment of governance subtly reinforced the monarchy’s centrality without explicit endorsement. For instance, a civics exam asked students to evaluate “the effectiveness of Saudi Arabia’s political system in ensuring stability and development.” Expected responses rarely framed legitimacy through popular consent; instead, they emphasized institutional efficiency, legal modernization, and economic performance. This omission reflected both censorship and strategic narrative control—avoiding questions of accountability that could destabilize the regime’s foundational claim. Yet it also revealed a deeper tension: how can a reformist agenda advance without confronting the political structures it depends on? Industry insiders echoed these concerns. In a closed-door forum with education reform advocates, a senior executive from a leading Saudi tech firm noted: “The papers prepare students for leadership roles, but few address how to navigate bureaucratic red tape, patronage networks, or resistance from entrenched interests. We hire graduates fluent in Vision 2030, but often struggle with the messiness of implementation.” This insight underscored a systemic disconnect: while the curriculum emphasized innovation, it afforded little space to critique or circumvent institutional inertia. International observers, particularly from human rights and academic freedom organizations, raised alarms about academic autonomy. Reports from groups such as Human Rights Watch and the Gulf Research Center documented cases where teachers self-censored or avoided sensitive topics—particularly on governance, human rights, and regional conflicts—fearing repercussions. A former educator quoted anonymously said: “We teach what the exam papers allow. Deeper debates about state power, political pluralism, or civil society remain off-limits. The result is compliance, not critical thinking.” This self-censorship, while ensuring exam success, risked producing a generation of leaders adept at strategic compliance but ill-equipped for pluralistic governance. Economists, too, questioned the disconnect between aspirational curricula and labor market realities. The PIF’s aggressive diversification into tech,

renewables, and entertainment created demand for experts in venture capital, intellectual property, and digital governance. Yet question papers emphasized state-led investment and public sector reform, with scant focus on private-sector entrepreneurship, market competition, or regulatory innovation. As Dr. Karim El-Sayed, a labor market analyst at King Abdullah University of Science and Technology, observed: “If we educate for Vision 2030 but fail to align assessments with private sector needs, we risk creating a mismatch—graduates who understand policy but not how to operate within dynamic, competitive
