document; Matthew and Luke reflect distinct theological agendas; John's prologue and Johannine community context suggest a more Hellenized, speculative articulation of Jesus' divinity. Critical scholarship distinguishes between the "Jesus of history"—a semi-mythical figure shaped by social and religious dynamics—and the "Christ of faith," a Christological construct refined through ecclesial councils and creeds. The 19th-century Documentary Hypothesis, advanced by scholars like Hermann Gunkel, posited multiple Gospel sources (such as the hypothetical "Source Q" and the "M" and "L" documents), arguing for a gradual compilation rather than a single, eyewitness account. This model remains foundational, underscoring that the texts we read today are editorial products, shaped by theological intent, audience needs, and transmission biases. Beyond the Gospels, external corroboration is sparse but significant. The only non-Christian reference to Jesus comes from the 1st-century historian Flavius Josephus, specifically in *Antiquities of the Jews* (c. 93–94 CE). In Book 18, chapter 3, Josephus cites a passage—now fragmentary and disputed—where he mentions "Jesus, who was a doer of wonderful works, a teacher of righteousness, and called the Christ." The full extant text reads: "James, the brother of Jesus, who was called Christ, was not difficult to interpret, for he did numerous works of a mighty nature, and he was the Christ." This reference, though brief, is pivotal: it confirms Jesus as a historical figure within first-generation Jewish historiography, even if Josephus's original text survives only in later Greek manuscripts with lacunae. Scholars debate the authenticity and interpretation of this passage. The term **Christ** (Christos) was a standard title for messianic claimants in the Roman Empire, deriving from **Christos**, the Greek equivalent of the Hebrew **Mashiach**. Josephus's use of "the Christ" likely denotes a title, not necessarily a messianic identity, and may reflect his neutral, reportorial stance. The reference to "James, the brother of Jesus" has fueled centuries of debate: James was likely James the Just, a leader of the Jerusalem church, but his historicity rests on patristic tradition (e.g., Clement of Rome, Origen) rather than independent evidence. Some argue this passage, even if authentic, does not confirm Jesus' existence but attests to a Jesus-shaped legend circulating among Jews and early believers. Archaeological evidence offers indirect but crucial context. The material culture of 1st-century Palestine—urban centers like Nazareth, Capernaum, and Jerusalem; rural villages; and the region's integration into the Roman imperial system—provides a backdrop to Jesus' life. Nazareth's emergence as a settlement is documented in Roman census records; the presence of synagogues, cisterns, and modest dwellings aligns with the socio-economic profile of a Galilean village. Roman occupation, marked by heavy taxation, military garrisons, and religious tensions, shaped the environment in which Jesus' teachings evolved. The Temple in Jerusalem stood as both spiritual epicenter and political flashpoint—its destruction in 70 CE marking a rupture that redefined Jewish identity and likely accelerated the formation of nascent Christian communities. Pilate's tenure (26–36 CE) was marked by brutality and provocation—tensions culminating in the Passover riots referenced in all four Gospels. The presence of Legio X Fretensis in Judaea, with its detachments in Caesarea Maritima, underscored Roman control. Jesus' itinerant ministry, preaching repentance and the coming Kingdom, likely provoked suspicion among both Jewish authorities and Roman administrators wary of sedition. His final act—entering Jerusalem during Passover, a festival with political overtones—may have been interpreted as a symbolic challenge to imperial authority. The evolution of Jesus' image over the first century reflects shifting theological and communal needs. Early Jesus figures appear in apocalyptic sects like the Qumran community, where a divinely anointed teacher (often called "Moshiach") was expected to restore Israel. Jesus of Nazareth, preaching in Galilee, may have begun as a localized preacher, but after his crucifixion, his followers reinterpreted his death and resurrection not as failure but as cosmic victory. The transformation from a crucified messiah figure to a resurrected Savior emerged within a

decade, evidenced by Paul's epistles (c. 50s CE), particularly Galatians and Romans, where Christology overtakes historical narrative. Paul himself is a pivotal figure in this evolution. A former Pharisee turned apostle, he never met Jesus but claimed a divine encounter on the road to Damascus (Acts 9). His letters, the earliest Christian texts, articulate a theological framework that transcends Jewish law and embraces Gentile inclusion—radical ideas that propelled Christianity beyond its Jewish roots. The tension between Pauline theology and the Jerusalem leaders (documented in Acts and Paul's letters) reveals the formative struggle to define Jesus' identity: was he a righteous teacher, a suffering martyr, or the divine Son of God? Scholarly consensus, particularly since the 19th century, affirms Jesus' historical existence through multiple lines of reasoning. Linguistic analysis confirms the Galilean-Jewish milieu of the Galilean Jesus; historical parallels show how itinerant preachers operated in similar contexts; and the non-Christian corroboration of James provides a non-theological anchor. However, the lack of contemporary non-Christian biographies or papyri mentioning Jesus—despite extensive records from Roman officials, Jewish historians, and local inscriptions—remains a constraint. The “silence of the sources” outside Christianity is notable; no Roman, Jewish, or Egyptian text from the period references him. Contemporary debates center on the “minimal facts” approach, championed by scholars like Richard Carrier and Gerd Lüdemann, which identifies nine core historical assertions: Jesus existed, was born to Joseph and Mary, was a Galilean preacher, performed miracles, taught a Kingdom message, was crucified under Pilate, his disciples believed him resurrected, appearances followed, and the movement grew rapidly. While uncontested by most scholars, critics argue this method risks overreach, assuming every element has evidence, even if fragmentary. The resurrection itself remains outside empirical verification, residing in faith rather than history. Expert perspectives vary widely. Bart Ehrman, a New Testament scholar, emphasizes textual reliability and historical context, concluding Jesus' existence is “unquestioned” among historians. N.T. Wright, an Orthodox theologian, argues for a robust historical Jesus grounded in Jewish messianic hopes and Roman-era archaeology. Conversely, critics like Michael Licona stress the need for caution, noting that while the evidence supports a historical figure, definitive proof remains elusive. The field remains dynamic, with new discoveries—such as the 2021 potential reference to “Jesus” on a 1st-century stone fragment from Judea—sparking renewed debate but not conclusive resolution.
