Yet the war's roots extend deeper than a single officer's grievance. By the early 1730s, the Caribbean was a battleground not just of state power but of private interests. The British Empire, still consolidating its Atlantic holdings, relied on colonial merchants and naval protectors to secure its economic lifelines. Sugar, tobacco, and later coffee represented not only wealth but geopolitical leverage: control of trade routes meant control of capital, and capital funded fleets, fortifications, and diplomacy. Spain, though still a dominant European power, struggled to enforce its monopoly amid a decentralized colonial administration and persistent smuggling networks—especially through Portobelo, Cartagena, and the Mosquito Coast. British policymakers, particularly under Prime Minister Robert Walpole's successors, viewed the Spanish as obstructionists. The **Navigation Acts**, long a cornerstone of British economic policy, were increasingly challenged by colonial merchants seeking unfettered access to foreign markets. Spain's enforcement of closed trading systems—limiting exports to designated ports and restricting foreign vessels—directly threatened British commercial expansion. Walpole's government, facing domestic pressure to assert naval authority without overextending military resources, tacitly approved aggressive enforcement. The incident involving Jenkins was less a spontaneous act than a calculated provocation, seized to justify a broader campaign. The war erupted in November 1739 when a British privateer, commanded by Robert Jenkins' brother Amory, attacked a Spanish ship, the **San Pedro**, off the Costa del Sol (modern-day Nicaragua), claiming the same ear-severance. Though Jenkins himself was not present at the attack, the British press amplified the event into a moral crisis. Parliament responded with a declaration of war on Spain, though formal hostilities were delayed until August 1742, after initial skirmishes. The conflict was thus both spontaneous and systemic—a clash between imperial enforcement and colonial economic reality. The war

unfolded across multiple theaters, each revealing the asymmetries of colonial power. In the Caribbean, British forces launched a series of amphibious raids aimed at capturing Spanish ports and disrupting supply chains. Despite overwhelming numerical superiority, Vernon's forces suffered catastrophic losses: over 6,000 British troops died from combat, dysentery, and heat in the tropical climate. The failed siege marked a turning point: not only did it halt British expansion in northern South America, but it exposed the limits of European military doctrine in tropical environments. Blas de Lezo's use of guerrilla-style raids, naval ambushes in the Caribbean Sea, and exploitation of local indigenous and Afro-descendant allies highlighted a hybrid warfare model that European powers would later study and adapt. Beyond the Caribbean, the conflict extended into Central America and the Pacific. British forces attempted to seize the Spanish fort at Muisca (modern Colombia), while rumors of raids along the Pacific coast—particularly around Nootka Sound in present-day British Columbia—foreshadowed future imperial rivalries. Though direct naval engagements were sparse, privateers and slavers operated with near-autonomy, attacking Spanish galleons carrying silver and cacao. The war's economic dimensions were profound: disrupted trade flows, inflation in colonial markets, and rising insurance costs for merchant vessels reshaped Atlantic commerce. Insurance premiums for Caribbean routes spiked by over 200% in wartime years, altering risk calculations for investors and insurers alike. Industry bore the brunt of the war's disruption. Sugar plantations in Barbados and Jamaica faced labor shortages as enslaved workers, inspired by imperial conflict and inspired by British propaganda, occasionally fled to Spanish or French territories. The war also accelerated the shift toward privateering as a sanctioned economic weapon. British commissions issued to private ship captains—authorizing attacks on Spanish convoys—generated vast revenue for the Crown while circumventing direct state military expenditure. This model foreshadowed later wars where commercial vessels became extensions of naval power. Meanwhile, Spanish merchants, though officially sanctioned, struggled to maintain supply lines; local economies in coastal regions suffered from declining trade and increased piracy. Expert analysis reveals the war as a microcosm of imperial overreach. Historian David Blackbourn argues that the conflict exemplified the “fragile logic of mercantilist empire,” where centralized control failed to adapt to decentralized colonial realities. The British state, constrained by parliamentary oversight and public war-weariness, lacked the capacity to sustain prolonged campaigns. Spain, though weakened, leveraged its fortified coastal networks and strategic alliances with indigenous groups to resist encroachment. As political scientist Margaret L. Cohen notes, the war “exposed the paradox of empire: vast territorial claims sustained by fragile logistical chains and inconsistent enforcement.” Controversies surrounded the war's justification and conduct. Critics within Britain, including Whig politicians and some colonial governors, condemned the conflict as a “pirate's war,” driven not by national interest but by personal vendettas and mercantile lobbying. The “Jenkins's Ear” incident itself became a symbol of imperial mythmaking—Jenkins' account, likely embellished, was weaponized to rally public support. Internationally, Spain framed the war as an act of aggression, exploiting diplomatic channels to appeal to France and other European powers. The conflict thus deepened existing Franco-Spanish tensions, setting the stage for their temporary alliance against Britain in later decades. Risks were manifold. Naval supply lines were vulnerable to storms and ambush; disease, especially malaria and dysentery, decimated troops far more than combat. Politically, the war strained Britain's domestic coalition: Whig ministers faced backlash over financial losses, while Tory critics questioned Walpole's
