Yet **Cancionero Picot** transcends genre. It emerged from the margins of a region where state violence, economic dependency, and cultural erasure converged into a lived reality that demanded expression beyond words. Its name, "Picot," references not a composer but a network—an informal collective of poets, musicians, and exiled intellectuals who operated in the shadows, risking imprisonment, disappearance, or death to document the silenced.
